

ARTICLE XI. AMENDMENT

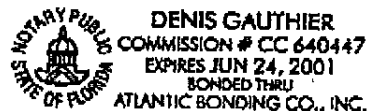


