SECOND: The Articles of Incorporation were filed on **July 20, 1998.**

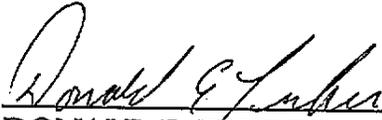
THIRD: The dissolution was authorized on **August 13, 1999.**

FOURTH: Adoption of Dissolution -

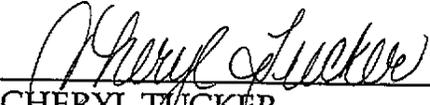
The Board of Directors proposed and recommended dissolution to the shareholders as authorized by a duly adopted corporate resolution.
