ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Jerry A. Riggs, Fr., P.A.

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be: 8647 S.W. 50th Street Cooper City, Florida 33328

ARTICLE III - PURPOSE
