**ARTICLES OF INCORPORATION**

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I. NAME**

The name of the corporation shall be: Joy Grubb, Inc. The principal place of business of this corporation shall be 840 Hickory Lane, Palm Harbor, Florida 34683.

**ARTICLE II. NATURE OF BUSINESS**

This corporation may engage or transact in any or all lawful activities or businesses permitted under the laws of the United States, the State of Florida or any other state, county, territory or nation.

**ARTICLE III. CAPITAL STOCK**

The maximum number of shares that this corporation is authorized to have outstanding at any one time is one thousand (1,000) shares of common stock having one dollar (\$1.00) par value per share.

**ARTICLE IV. ADDRESS**

The street address of the initial registered office of the corporation shall be 840 Hickory Lane, Palm Harbor, Florida 34683. The name of the initial registered agent of the corporation at that address is Joy Grubb.

**ARTICLE V. TERM OF EXISTENCE**

This corporation is to exist perpetually.

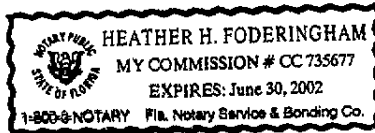
