

ARTICLES OF INCORPORATION

FOR

ARICLE I

NAME AND PRINCIPAL OFFICE ADDRESS

The name of the corporation is: Rulo Sales, Inc., located at 1546 Dexel Road, West Palm Beach, FL, 33417.

ARTICLE II
