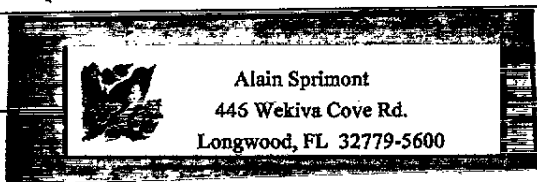

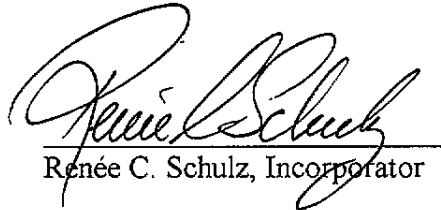

OF
MICRO ACCESS, Inc.**

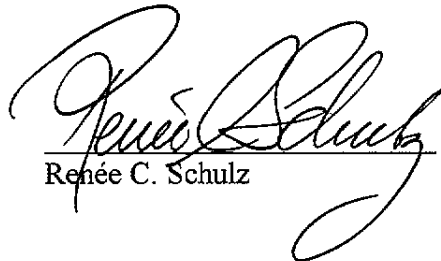
- FIRST:** The name of this corporation is MICRO ACCESS, Inc.
- SECOND:** This corporation is organized for the purpose of engaging in the business of the exportation of electronic components, computer components to Europe, and for the purpose of engaging in any and all lawful business for which corporations may be formed under Chapter 607 of the Florida Statutes.
- THIRD:** This corporation is authorized to issue 50,000 shares of common stock, par value \$1.00 per share.
