ARTICLE THREE

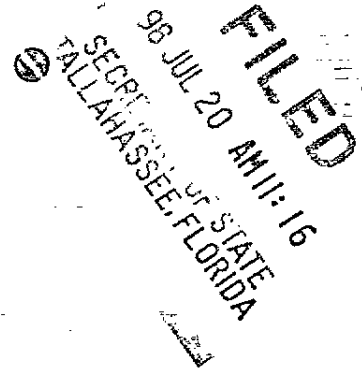
The purpose for which the corporation is the transaction of any lawful business for which corporations may be incorporated under the Florida Corporation Act. The type of business to be transacted is architectural services.


