The undersigned, being of legal age and competent to contract, for the purpose of organizing a corporation pursuant to the laws of the State of Florida, does hereby adopt the following Articles of Incorporation, and does hereby agree and certify as follows:

ARTICLE I. NAME

The name of this Corporation shall be OUTBOUND LOGISTICS, INC.

ARTICLE II. COMMENCEMENT OF CORPORATE EXISTENCE

This Corporation shall commence corporate existence upon the 17th day of July, 1998, and shall have perpetual existence unless sooner dissolved according to law.
