Name and Address



Michael Schwartz, M.D., P.A. shall be a personal service medical corporation specializing in the practice, consulting and education as it relates to the field of neurology.



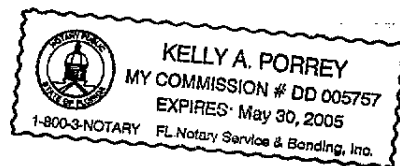
