ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned have this day formed a corporation for the transaction of business, and the promotion and conduct of the objects and purposes hereinafter stated, under and pursuant to the laws of the State of Florida,

AND WE DO HEREBY CERTIFY THAT:

ARTICLE I

The name of the corporation, which is hereafter referred to as "the corporation" is GAMERA CORPORATION

ARTICLE II

The principal office and place of business of the corporation shall be at 3230 U.S. Highway 27 South, Lake Wales, Florida 33853 with a mailing address of 3230 U.S. Highway 27 South, Lake Wales, Florida 33853.

Offices for the transaction of any business of the corporation and where the meeting of the Board of Directors and the stockholder may be held, and where the books of the corporation may be kept, may be established and maintained in any other part of the State of Florida, or any other state, territory or possession of the United States of America, the District of Columbia, or in any foreign country.

ARTICLE III

The nature of the business and objects and purposes proposed to be transacted, promoted or carried on by the corporation are:

To engage in any lawful activity.

ARTICLE IV

The amount of the total authorized capital stock of this corporation is 8000 shares with one-dollar (\$1.00) par value. Each share of stock shall have on (1) vote. Such stock may be issued from time to time without any action by the stockholders for such consideration as may be fixed from time to time by the Board of Directors, and shares so issued, the full consideration for which has been paid or delivered, shall be deemed the full paid up stock, and the holder of such shares shall not be liable for any further payment thereof. Said stock shall not be subject to assessment to pay the debts of the corporation, and no paid-up stock and no stock issued as fully paid shall ever be assessed or assessable by the corporation. The initial issue of stock shall be 100 shares issued to Rafael Iglesias fifty-one (51) shares, Jorge Gamez and Fernando Gamez forty-nine (49) shares.

ARTICLE V

The governing board of this corporation shall be known as directors, and number of directors may from time to time be increased in such manner as shall be provided by the bylaws of this corporation, provided that the number of directors shall not be reduced to less than 2, except that in cases where all the shares of the corporation are owned beneficially and of record by either one or two stockholders, the number of directors may be less than 2 but not less than the number of stockholders. ARTICLE VII

The corporation is to have perpetual existence.

ARTICLE VIII

- 1. The Board of Directors shall have the power and authority to make and alter, or amend, the bylaws, to fix the amount in cash or otherwise, to be reserved as working capital, and to authorize and cause to be executed the mortgages and liens upon the property and franchises of the corporation.
- 2. The Board of Directors shall, from time to time, determine whether, and to what extent, and at which times and places, and under what conditions and regulations, the accounts and books of the stockholders; and no stockholder shall have the right to inspect any account, book or document of this corporation except as conferred by statues of Florida, or authorize by the directors or by resolution of the stockholders.
- 3. No sale, conveyance, transfer, exchange or other disposition of all or substantially all of the property and assets of this corporation shall be made unless approved by the vote or written consent of the shareholders entitled to exercise two-thirds (2/3) of the voting power of the corporation.

The stockholders and directors shall have the power to hold their meetings, and keep the books, documents and papers of the corporation outside of the State of Florida and at such place as may from time to time be designated by the bylaws or by the resolution of the Board of Directors or stockholders, except as otherwise required by the laws of the State of Florida.
