**ARTICLES OF INCORPORATION
OF
LUCKY 8 FARMS, INC.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopts the following articles of incorporation:

**ARTICLE I
NAME**

The name of the corporation shall be LUCKY 8 FARMS, INC..

**ARTICLE II
DURATION**

The term of existence of the corporation shall be perpetual.

**ARTICLE III
PURPOSE**

The general purposes for which the corporation is organized are:

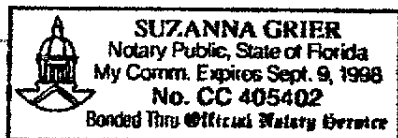
