ARTICLES OF INCORPORATION
OF
U.S. LAWN OF ST. LUCIE COUNTY, INC.

The undersigned Incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I. NAME

The name of this corporation shall be: U.S. LAWN OF ST. LUCIE COUNTY, INC.

ARTICLE II. INITIAL REGISTERED OFFICE AND MAILING ADDRESS

The street address of the initial registered office of this corporation is 1520 S.W. Belgrave Terrace, Stuart, FL 34997. The mailing address of this corporation is 1520 S.W. Belgrave Terrace, Stuart, FL 34997.

ARTICLE III. CAPITALIZATION

The aggregate number of shares which the corporation is authorized to issue is 10,000. Such shares shall be of a single class, and shall have a par value of \$1.00 per share.

ARTICLE IV. PREEMPTIVE RIGHTS

Every Shareholder, upon the sale for cash by this corporation of any shares of new capital stock of the same kind, class, or series, as that which the shareholder already holds, shall have the preemptive right to purchase a pro rata share thereof (as nearly as may be done without the issuance of fractional shares) at the price at which such shares are offered to others.

The duration of the corporation is perpetual.


ARTICLE X. MEETINGS BY CONFERENCE TELEPHONE

ARTICLE XI. INDEMNIFICATION




