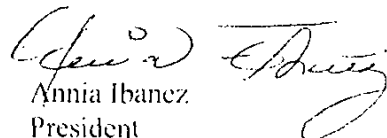
We have received your second notice for the Uniform Business Report (UBR) 2000.

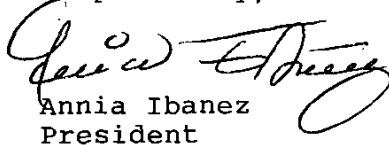
