### ARTICLES OF INCORPORATION

The undersigned, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation pursuant to the provisions of the Florida Professional Service Corporation Act, and other laws of the State of Florida.

## ARTICLE I Name

The name of the corporation shall be Mark A. Scribano, D.V.M., P.A.

# ARTICLE II Principal Office

The principal place of business of the corporation shall be 1401 Fourth Street North, St. Petersburg, Florida 33704-4495, and the mailing address of the corporation shall be 2000 Hawaii Avenue N.E., St. Petersburg, Florida 33703.

## ARTICLE III Purpose

The purposes for which the corporation is organized shall be:

- (a) to engage in every phase and aspect of the business of rendering the same professional services to the public that a veterinarian duly licensed under the laws of the State of Florida, is authorized to render, but such professional services shall be rendered only through officers, employees, and agents who are duly licensed under the laws of the State of Florida to practice veterinary medicine therein.
- (b) to invest the funds of the corporation in real estate, mortgages, stocks, bonds, or any other type of investment, and to own real and personal property necessary for the rendering of professional veterinary services.
- (c) to do everything necessary and proper for the accomplishment of any of the purposes or the attaining of any of the objects or the furtherance of any of the purposes enumerated in these Articles of Incorporation or any amendment thereof, necessary or incidental to the protection and benefit of the corporation, and in general, either alone or in association with other corporations, firms, or individuals, to carry on any lawful pursuit necessary or

incidental to the accomplishment of the purposes or the attainment of the objects or the furtherance of such purposes and objections of the corporation.

## ARTICLE IV Duration

The duration of the corporation shall be perpetual.

## ARTICLE V Capital Stock

The number of shares of stock that the corporation is authorized to issue is 10,000, all of which are of a par value of \$.10 each and are of the same class and are common shares. None of the shares of the corporation may be issued to anyone other than an individual duly licensed to practice veterinary medicine in the State of Florida.

## ARTICLE VI Initial Registered Agent and Office
