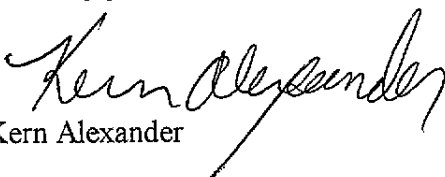

The undersigned incorporators hereby adopt the following Articles of Incorporation for the purpose of forming a corporation under the Florida Business Corporation Act.

Article I Corporate Name

The Name of the corporation shall be:

AWHO, Inc.

Article II Principal Office

Article III Capital Stock

The number of shares of stock that this corporation is authorized to have outstanding at any one time is:

100 Shares of Common Stock which shall have a Par Value of 1 cent per Share.

Article VI Preemptive Rights

After the first shares of this Corporation are issued, each holder of the shares will have the first right to purchase additional shares of this Corporation that may be issued from time to time. Each such holder of shares may purchase an amount equal to (1) the total additional shares times (2) the ratio existing between the number of shares he holds at the time for the new issue and the number of shares outstanding. This first right to purchase will be deemed waived by any Shareholder who does not exercise it, or who does not pay for the shares preempted, within 30 days of receiving written notice from the Corporation stating the prices and terms of the issue of shares and inviting him/her to exercise its preemptive rights.

Article VII Personal Liability of Shareholders

The personal liability of the shareholders shall be limited to the value of the shares they hold in the corporation.

Article VIII Management of the Corporation

The management and direction of the corporation shall be conducted based on decisions made by the Directors and Shareholders of the Corporation. No decision to manage and direct the corporation shall be valid unless approved by either shareholder or shareholders which own not less than 2/3 (two-thirds) to the shares issued by the corporation.

The shares in the Corporation will not be issued for consideration other than money or payment of a debt of the Corporation without the unanimous consent of all of the Shareholders of the Corporation.
