Pursuant to the provisions of Sections 607.1003 and 607.1006, Florida Statutes, WRH Mount Vernon, Inc., a Florida corporation (the "Corporation"), hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is WRH Mount Vernon, Inc.
2. The Articles of Incorporation of the Corporation were filed with the Florida Secretary of State on July 22, 1998 and assigned Document No. P98000064621.
3. The following amendment to the Articles of Incorporation of the Corporation is hereby adopted, effective with the filing of these Articles of Amendment to the Articles of Incorporation with the Florida Secretary of State:

Article I is hereby deleted in its entirety and the following is substituted therefore:

Article I - Name
