ARTICLES OF INCORPORATION

OF

BREVARD CAPITAL, INC.

ARTICLE I

Name

The name of this Corporation is Brevard Capital, Inc.

ARTICLE II

Duration

This Corporation shall have perpetual existence.

ARTICLE III

Purpose


