'BEFORE ME, the undersigned authority, this day personally appeared Vivian Fragano & Zaira Lombardo, first by me being duly sworn deposes and says:


1. That affiants are the President/Vice-President/Treasurer/ Secretary/Directors of Digrafico, Inc. who has on the date filed the dissolution of the company.
