I am enclosing the Profit Corporation Annual Report for 1998 along with a check for \$150 made payable to Department of State.

It has come to my attention that the filing fee for annual reports that are filed after May 1st was recently increased to \$550, which translates to a penalty of \$400. In turn, this \$400 penalty translates to a 267% penalty.

First, because it is this corporation's first year in business, they we were just recently able to procure the services of office help and simply became overwhelmed with the paperwork involved in starting a new business. Second, one of the sole stockholder's family members has been critically ill since the beginning of the year. Attempting to get a new business off the ground while participating in the care of an ill family member resulted in the late filing of this report. Last, I believe that the extent of this penalty is ludicrous when you compare it to the laws that we uphold and challenge based on the definition of usury.

For the above reasons, I have enclosed the \$150 fee only and respectfully request that you provide for the abatement of this outlandishly pricey penalty. If you wish to discuss this matter further, please call me at (850) 893-1694 during business hours.
