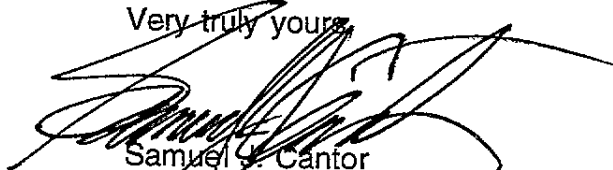

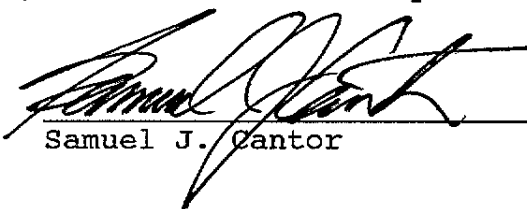
ARTICLE VIII

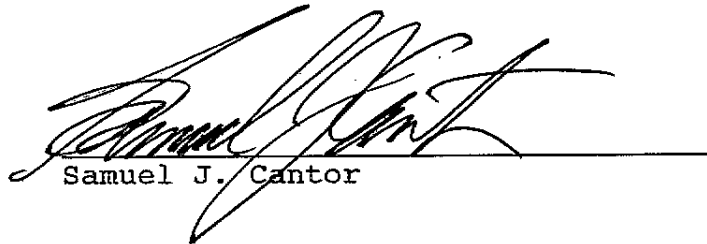
