## SECOND AMENDMENT TO THE ARTICLES OF INCORPORATION

#### **FOR**

## KRIS INTERNATIONAL, INC.

#### A FLORIDA FOR-PROFIT CORPORATION

Pursuant to the provisions of Chapter 607 of the Florida Statutes, as amended, KRIS INTERNATIONAL, INC, (hereinafter Corporation) by and through its shareholders hereby adopts the following Second Amendment to the Articles of Incorporation for the above-referenced corporation as follows:

### ARTICLE III: SHARES OF STOCK

This Corporation shall have the authority to issue Nine Hundred (900) shares of Common Stock in addition to the 100 previously authorized shares for a total of One Thousand (1,000) shares, \$1 par value per share, of which Five Hundred (500) shares (including the 100 previously authorized shares) shall be voting Common Stock ("Class A Common Stock") and Five Hundred (500) shares shall be non-voting Common Stock ("Class B Common Stock"). Such shares of Common Stock are hereinafter collectively referred to as the "Capital Stock."

The holders of Class A Common Stock and Class B Common Stock shall have identical rights with respect to (a) distributions from the Corporation; (b) the liquidation of the Corporation; and (c) all other matters affecting the Corporation, except that the holders of the Class B Common Stock shall not be entitled to vote on any matters affecting the Corporation (except as otherwise required by Florida law).
