

**ARTICLES OF INCORPORATION
OF
ALL FLORIDA DIAGNOSTICS, INC.**

ARTICLE I - NAME

The name of this corporation is All Florida Diagnostics, Inc.

ARTICLE II - DURATION

This corporation shall exist in perpetuity commencing on the date set forth in Article XIII of these Articles.

ARTICLE III - PURPOSE

ARTICLE XIV - AMENDMENT


