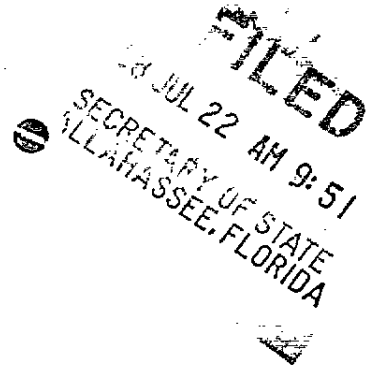

**ARTICLES OF INCORPORATION**  
**OF**

**ARTICLE 1. - NAME**

The name of the corporation is PROFFITT OF BRADENTON, INC.

**ARTICLE 2. - PRINCIPAL OFFICE**

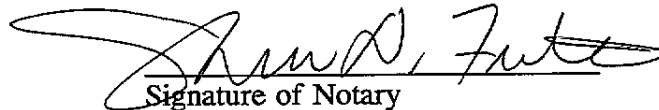
