The undersigned acting as subscriber of a corporation under the Florida Corporation Law adopts the following Articles of Incorporation for the above-titled corporation.

ARTICLE I

The name of this corporation shall be: THE FIFTH COMMANDMENT, INC.

ARTICLE II

The principle place of the business of the corporation shall be situated at: 102 Tree Tops Lane, Ashville, North Carolina, 28803.

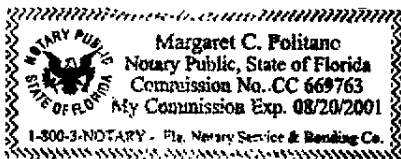


