ARTICLES OF INCORPORATION

OF

MIDNIGHT PIZZA ENTERPRISES, INC.

The undersigned incorporators hereby form and organize a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is MIDNIGHT PIZZA ENTERPRISES, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal office of the corporation is 102 North Marion Street, Lake City, Florida 32055, and the mailing address of the corporation is 102 North Marion Street, Lake City, Florida 32055.

ARTICLE III - PURPOSE

The general purposes for which this corporation is organized and the nature of the business to be transacted by it are any and all lawful activities or businesses permitted by the law and the corporation shall have the power and authority to do any and all things to the same extent as a natural person.

It is the intention of this article that the powers and nature of the business of this corporation shall not in any way be restricted or limited except by operation of law and the corporation shall have all powers as may be granted either now or hereafter to corporations by the laws of the State of Florida.

Authorized capital stock may be paid for in cash, services, or property, at a just value, but not less than par value, to be fixed by the Board of Directors of this corporation.

Every shareholder, upon the sale of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE V - REGISTERED OFFICE AND AGENT

The street address of the registered office of the corporation is 104 North Marion Street, Lake City, Florida 32055. The registered agent of the corporation at such office is Michael J. Testoni. The registered agent, by signing these Articles of Incorporation, accepts appointment as such and certifies that he is familiar with and accepts the duties and responsibilities as registered agent for the corporation.
