ARTICLES OF INCORPORATION
OF
SOUTHERN COMFORT ENDEAVORS, INC.

ARTICLE I.

NAME

The name of this corporation is Southern Comfort Endeavors, Inc.

ARTICLE II.

PRINCIPAL OFFICE

The initial principal office and mailing address of this corporation is 5912 New Kings Road, Jacksonville, Florida 32209.

ARTICLE III.

COMMENCEMENT OF EXISTENCE

The existence of the corporation commences on execution by the incorporator unless the filing of these Articles of Incorporation occurs more than five (5) business days thereafter, in which event such existence commences on the date of filing of these Articles of Incorporation.

ARTICLE IV.

CAPITAL STOCK

This Corporation is authorized to issue an aggregate of Ten Thousand (10,000) shares of capital stock, divided as follows:

- A. One Thousand (1,000) shares of Voting Common Stock, par value \$1.00 per share ("Voting Common Stock"); and
- B. Nine Thousand (9,000) shares of Non-Voting Common Stock, par value \$1.00 per share ("Non-Voting Common Stock").

Without action by the shareholder(s), any or all of the authorized shares may be issued by this corporation from time to time for such consideration as may be fixed by the Board of Directors of this corporation.

ARTICLE V.

INITIAL REGISTERED OFFICE AND AGENT

The initial registered office of this corporation in the State of Florida is Suite 3000, One Independent Drive, Jacksonville, Florida 32202 and the name of the initial registered agent of this corporation at that address is Haley A. Watkins. The Board of Directors may, from time to time, change the registered agent or move the registered office to any other address in Florida.


