**ARTICLES OF INCORPORATION OF
DRAGWAY SPEED CENTER, INC.**

The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME: The name of the corporation is Dragway Speed Center, Inc.

ARTICLE II

PRINCIPAL OFFICE: The principal place of business and mailing address of this corporation shall be 2101 19th St., Sarasota, FL 34234

ARTICLE III

SHARES: The corporation is authorized to issue 7,500 shares of stock having a par value of \$1.00 per share, all of which shall be common shares.

ARTICLE IV

DURATION: The corporation shall exist perpetually.

ARTICLE VII

PURPOSE: The corporation is organized for the purposes of transacting any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE VIII

BOARD OF DIRECTORS: The corporation shall have one director initially. The number of directors may be increased or decreased from time to time by the bylaws, but shall never be less than one. The name and address of the initial director of the corporation is: Vincent J. Seco, 362 Suwanee Ave., Sarasota, FL 34243

ARTICLE IX

OFFICERS: The officers of the corporation shall be a president, a secretary, a treasurer and such other officers and agents as may be deemed necessary and proper provided for in the bylaws of the corporation. All officers and agents as may be deemed necessary shall be chosen in such manner, hold their offices for such terms, and have such powers and duties as may be prescribed by the bylaws of the corporation or determined by the Board of Directors. Any person may hold two or more offices.

ARTICLE X

AMENDMENT: The corporation reserves the right to amend, alter, change or repeal any provision contained in these Articles of Incorporation in the manner now or hereafter prescribed by law, and all rights conferred on stockholders herein are granted subject to this reservation. The Board of Directors shall have the power to adopt, alter or repeal bylaws.

ARTICLE XI

CORPORATE EXISTENCE: This corporation shall commence its existence at the time of filing these Articles of Incorporation with the Department of State, Division of Corporations, State of Florida.
