ARTICLES OF INCORPORATION

OF

EDROU LAND CORP.

ARTICLE I

CORPORATION NAME

The name of the Corporation is EDROU LAND CORP.

ARTICLE II

<u>PURPOSE</u>

This Corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.
