## **ARTICLES OF INCORPORATION**

*The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.*

### **ARTICLE I    NAME**

The name of the corporation shall be: A-PLUS COMPUTER TECHNOLOGIES, INC.

### **ARTICLE II    PRINCIPAL OFFICE**

## **ARTICLE V INCORPORATOR(S)**

The purpose of this corporation is to provide all of the technical system and support needs of the clients. This corporation will accomplish this purpose by providing on-site computer technical services, with the goal of client satisfaction, while generating a profit.

This corporation will maintain an S Corporation status until a majority vote by the initial incorporators listed above, the Board of Directors, and the Shareholders has been reached, which in turn has decided to change this status due to future requirements.

## **CORPORATE PROVISIONS**

Provision I: Management of this corporation will be directed and regulated by the initial three incorporators: Paul M. Downey, Bradley D. Howerter, and Craig A. McGuire. Although the Board of Directors and the shareholders have the right to vote on issues concerning management and regulations, these three initial incorporators have an indefinite vested interest in this corporation and therefore will always have the final vote for issues and/or regulations.

Provision II: The voting process by the three initial incorporators, listed in Provision I, will hereby require all three incorporators to agree before any issue and/or action can be executed in this corporation. The vested interest by the incorporators is as follows: Paul M. Downey 40%, Bradley D. Howerter 30%, and Craig A. McGuire 30%, therefore equaling 100% of the corporation. Although the shares are balanced to give the Chairman/President more shares for his experience and capital, no decision and/or action can be made without the consent and authorization of at least one other Vice-President, of the names listed in Provision I.

Provision III: The three initial incorporators, listed in Provision I, have the unlimited power and/or rights to change any policy, regulation, or guidelines at anytime, as long as they follow correct voting procedure in Provision III.

Provision IV: The corporation has the power to issue stock in one share class only, in accordance with the Internal Revenue Service requirements for a S Corporation.

Provision V: The Board of Directors have the authority to vote on certain regulated items, to be determined by the three initial incorporators, listed in Provision I.

Provision VI: The Board of Directors shall be responsible for maintaining the rights of the shareholders. They should make decisions for the best interest of the company, as well as for the shareholders.

Provision VII: The Board of Directors has the authority to remove anyone from the company, except the three initial incorporators listed in Provision I. Their removal power may be overturned by one of the initial incorporators.

Provision VIII: The Shareholders will receive dividends based on the voted decisions of the Board of Directors, and/or the Initial Incorporators listed in Provision I.

Provision IX: The Par Value is \$1.00 per share and the shares are A class shares. There will only be one class of shares in accordance with the Internal Revenue Service requirements for a S Corporation.

Provision X: This corporation (A-Plus Computer Technologies, Inc.), the Board of Directors, and the three initial incorporators: Paul M. Downey, Bradley D. Howerter, and Craig A. McGuire, will not be held responsible for any personal liability to the shareholders. For further clarification, refer to Provision XII.

Provision XI: All shareholders who purchase shares of stock in this corporation do so at their own risk.

Provision XII: All other bylaws will be listed in the corporation policy and procedure manual, which will be updated by the three initial incorporators as required.

**ARTICLE VI      EFFECTIVE DATE**

The effective start date of this corporation is the 1ST day of AUGUST, 19 98.

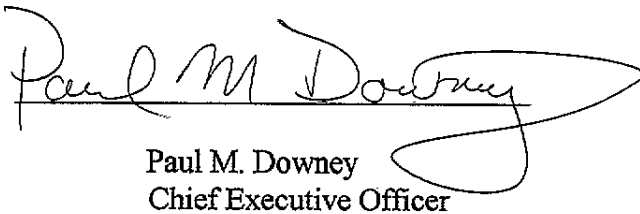
