The name of this Corporation is AABJM, Inc.

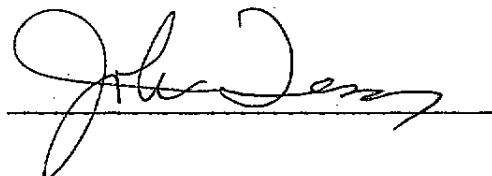
