**ARTICLES OF INCORPORATION**

**OF**

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby associate themselves to form a corporation under the laws of the State of Florida.

**ARTICLE I**

**NAME:** The name of this corporation is:

**ARTICLE II**

**PURPOSES AND POWERS:** The general nature of business to be permitted by the operation is as follows:

1. The corporation may engage in any activity or business which is permitted under the laws of the State of Florida.
2. And, in general, to carry on any other business in connection with the foregoing of which calculated, directly or indirectly, to promote the interest of the corporation or to enhance the value of its properties.
3. 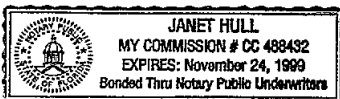

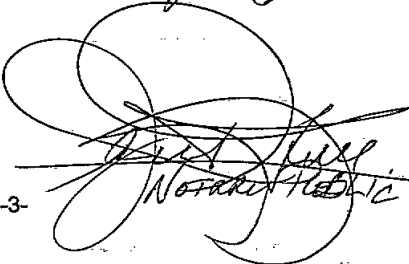
