ARTICLE I

Name

1.1 The name of the corporation is Capri Assets, Inc.

ARTICLE II

Duration

2.1 This corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation with the Department of State of Florida.

Indemnification

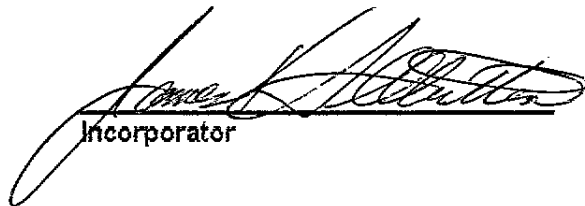

Amendment

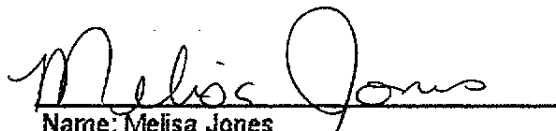
This corporation reserves the right to amend or repeal any provisions contained in these Articles, or any amendment to them, and any right conferred upon by the shareholders is subject to the reservation.

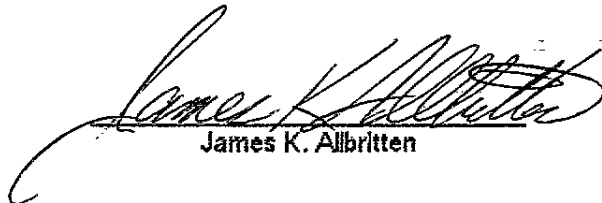

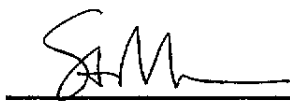
