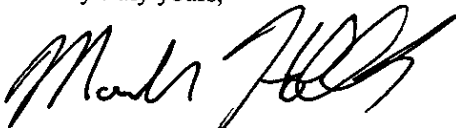
At this time, we want to wipe the slate clean, renew his corporation.
