We received your 2000 Uniform Business Report form, which bills us for \$550.00 instead of the base fee of \$150.00. We were nearly certain that we did not receive the original UBR, so I called your office concerning this. I was told by your office to send a check for \$150.00 along with a letter of explanation. Enclosed is the 2000 UBR and our check for \$150.00.

Had we received the original UBR from you we definitely would have sent payment prior to the due date of May 1st. We have five corporations for which the accounts payable are handled through the same procedures and same accounting personnel.
