**I.
Name**

The name of the Corporation is Orlando General Consulting & Services, Inc., hereinafter referred to as the "Corporation."

**II.
Purposes**

The purpose of the Corporation is to transact any and all lawful business for which corporations may be incorporated under the laws of the State of Florida, as they may be amended from time to time.

**III.
Principal Office and Registered Agent**

The principal office of the Corporation is 1111 Guernsey Street, Orlando, Florida 32804. The Corporation may maintain offices and/or transact business at other locations, either within or without the State of Florida. The name and address of the registered agent for service of process upon the Corporation is Stephen E. Avera, Sr., 1111 Guernsey Street, Orlando, Florida 32804.

**IV.
Duration**

The duration of the Corporation shall be perpetual.

**V.
Initial Business**

The initial business of the Corporation shall be:

- a. to engage in and transact any lawful business for which corporations may be incorporated under the laws of the State of Florida, as they may be amended from time to time.
- b. to do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

VI.
Capital Stock

The Corporation is authorized to issue only one class of shares of stock which shall be designated Common Stock. The total number of shares the Corporation shall have authority to issue is 100, each share to have a par value of \$1.00.

The private property of the stockholders shall not be subject to the payment of corporate debts.

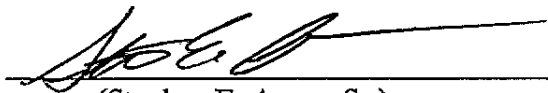
