The name of this corporation is:

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation.

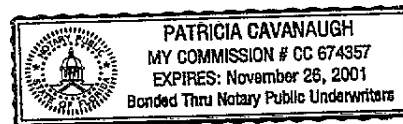
