CERTIFICATE OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF 330 WEST HIALEAH, INC.

a30 WEST HIALEAH, INC., a Florida corporation, by the hand of its Vice President and under the provisions of the Florida Statutes (1997), hereby certifies that all of the Shareholders entitled to vote have unanimously adopted the following amendment to the Articles of Incorporation filed on July 28, 1998.

1. Section 1 of Article III is deleted in its entirety and the following language inserted:
