ARTICLES OF INCORPORATION  
OF  
LINCOLN SUPPLY & EXPORT, INC.

ARTICLE I. NAME: The name of this corporation is LINCOLN SUPPLY & EXPORT, INC.

ARTICLE II. DURATION: This corporation shall have perpetual existence.

ARTICLE III. PURPOSE: This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV. CAPITAL STOCK: This corporation is authorized to issue One Hundred (100) shares of common stock having a par value of One Dollar (\$1.00) per share.

ARTICLE V. 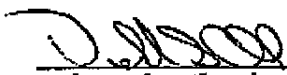
