Articles of Incorporation of Pristine Motors, Inc.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation shall be Pristine Motors, Inc.

ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 1340 S.W. 28th Avenue, Ft. Lauderdale, Florida 33312.

ARTICLE III. SHARES

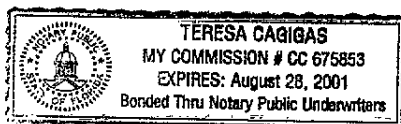
