ARTICLE I - NAME

The name of the corporation is F. MEADE ENTERPRISES, INC.

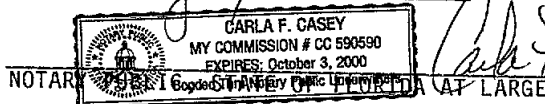
