ARTICLE I - NAME

The name of this corporation is Cl2 OPERATING SYSTEMS, INC., located at 101 Maplewood Dr., Sanford, Florida, 32771.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing with the filing of these Articles of Incorporation by the Florida Department of State pursuant to the laws of the State of Florida.

ARTICLE III - PURPOSE
