ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
CRAMER & CRAMER, P.A.

CRAMER & CRAMER, INC., a Florida corporation (the "Corporation"), by and through its President, hereby adopts an amendment to its Articles of Incorporation as hereinafter set forth.

1. Pursuant to Section 607.1003 of the Florida Statutes, the Board of Directors of the Corporation and the shareholders of the Corporation, in accordance with Sections 607.0821 and 607.0704 of the Florida Statutes, on February 3, 1998, adopted an amendment to Article I of the Articles of Incorporation of the Corporation, as amended. Article I is hereby deleted in its entirety and the following is substituted therefor:

ARTICLE I - Name

The name of the Corporation shall be:

DAVID G. CRAMER, P.A.

2. Except as modified hereby, the Articles of Incorporation of the Corporation shall be and remain in full force and effect.

3. The number of votes cast for the amendment by the shareholders was sufficient for approval, and the Corporation's shareholders are not divided into different voting groups.
