The undersigned, desiring to form a corporation under the laws of the State of Florida, hereby certify as follows: __

FIRST: The name of the corporation is: **QUALITY BUILT BY DESIGN, INC.** —

SECOND: The corporate existence of the corporation shall commence upon the filing of these articles by the Department of State and the duration of the corporation is perpetual.

THIRD: The purpose for which this corporation has been formed is to engage in any or all lawful business for which a corporation may be incorporated under Chapter 607, Florida Statutes.


FOURTH: There shall be a Board of Directors of the corporation, consisting of one member, and all corporate powers shall be exercised by or under the authority of the Board of Directors, and the business and affairs of the corporation shall be controlled by the Board of Directors. The number of members of the Board of Directors may be changed from time to time, as provided in the By-Laws. The corporation shall indemnify all officers, directors, former officers, and former directors, to the full extent permitted by law.

FIFTH: The aggregate number of shares which the corporation shall have authority to issue is Five Thousand (5,000) shares of common stock having a par value of One Dollar (\$1.00) per share. Shares of stock issued hereafter to shareholders may not be resold or otherwise transferred unless such shares first are offered for sale to the corporation. The price and terms of sale, and the time in which such sale is to occur, shall be as specified in the By-Laws.

SIXTH: The street address of the corporation's principal office and registered office is 2632 Cayman Way, Winter Park, Florida 32792 and the name of the corporation's registered agent at that address is Richard L. Krampe.

SEVENTH: The name and address of the corporation's sole incorporator is Richard L. Krampe, 2632 Cayman Way, Winter Park, Florida 32792.


