**ARTICLES OF INCORPORATION**

I, the undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

**ARTICLE I.**

**Name of Corporation**

The name of this corporation shall be *DYNAMIC POWER, INC.*

**ARTICLE II**

**PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be 4135 Miraflores Lane, Tallahassee, Florida 32303.

**ARTICLE III.**

**Term of Existence**

The duration of the corporation shall be perpetual. This corporation begins its corporate existence the same date as the filing of these articles of incorporation with the Florida Department of State.

**ARTICLE IV.**

**General Purpose**

This corporation may transact any or all lawful business for which corporations may be incorporated under the laws of the State of Florida and shall have those general powers conferred upon corporations under the laws of the State of Florida.

**ARTICLE V.**

**Capital Stock**

The aggregate number of shares of capital stock which this corporation is authorized to issue is One thousand (1,000) shares. Such shares shall be of a single class, and shall have a par value of One Dollar (\$1.00) per share.

**ARTICLE VI.**

**Registered Office and Registered Agent**
