The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

**ARTICLE I - NAME**

The name of the corporation is REPO SAVERS, INC. whose business address is 4411 Hidden Shadow Drive, Tampa, Florida 33614 and mailing address is 4411 Hidden Shadow Drive, Tampa, Florida 33614.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation by the Department of the State of Florida.

**ARTICLE III - PURPOSES**

The purpose or purposes for which the corporation is organized is a referral service for re-financing money loans and to do everything necessary, proper, advisable or convenient for the accomplishment of said purpose, and to do all other things incidental to this or connected with this that are not forbidden by the Florida corporation laws or by other laws, or by those Articles


