### ARTICLES OF INCORPORATION

### EURO XII, INC.

The undersigned, acting as the incorporator of Euro XII, Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

### ARTICLE I. NAME

The name of the corporation is:

Euro XII, Inc.

### ARTICLE II. PURPOSE


