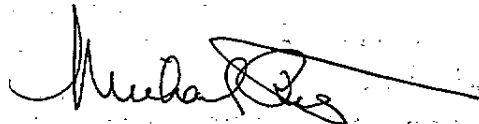

**ARTICLES OF INCORPORATION
OF
GULFSHORE IT SOLUTIONS, INCORPORATED**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following articles of incorporation:

**ARTICLE ONE
NAME**

The name of the corporation is **GULFSHORE IT SOLUTIONS, INCORPORATED**

**ARTICLE TWO
EFFECTIVE DATE**

The effective date of this corporation shall be on the filing of these articles of incorporation with the Secretary of State of Florida.

**ARTICLE THREE
CORPORATE DURATION**

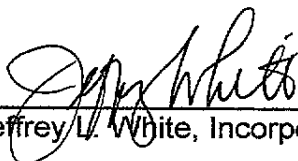

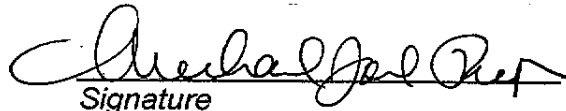

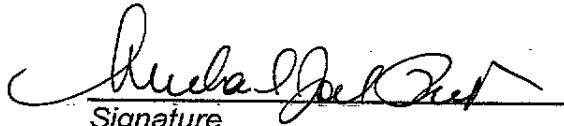
