ARTICLES OF INCORPORATION

The undersigned, desiring to form a professional services corporation for profit pursuant to the Laws of the State of Florida and in accordance with the Professional Service Corporation Act, do hereby certify as follows:

ARTICLE I

The name of the Corporation shall be: TODD C. DILEO, P.A.

ARTICLE II

The Corporation shall be entitled to render professional services as Chiropractor as permitted under the laws of the State of Florida. The professional services may only be rendered through its officers, employees and agents who are duly licensed or otherwise legally authorized to render such services within the State of Florida.

ARTICLE III

The capital stock of the Corporation shall be divided into shares of \$1.00 par value, with 7500 shares of common stock authorized, and each share shall entitle the holder thereof to vote at any meeting of the stockholders. All or any part of said capital stock may be paid for in cash, with property or in labor or services, at a valuation fixed by the incorporators or by the Board of Directors, at a meeting called for such purpose. All stock when issued shall be fully paid for and shall be non assessable.

ARTICLE IV

The amount of capital with which this Corporation shall begin business will be a minimum of \$100.00. No capital stock may be issued to anyone other than an individual or individuals who are duly licensed as Chiropractor or otherwise legally authorized to render Chiropractic services within the State of Florida.

The Corporation shall have perpetual existence.
