THE UNDERSIGNED INCORPORATOR OF THESE ARTICLES OF INCOR-PORATION IS A NATURAL PERSON COMPETENT TO CONTRACT AND HEREBY FORMS A CORPORATION FOR PROFIT UNDER THE GENERAL CORPORATION ACT AND OTHER LAWS OF THE STATE OF FLORIDA.

#### ARTICLE I. NAME
