

ARTICLES OF INCORPORATION
OF
ASSURED EQUITY, INC.

ARTICLE I. NAME

The name of this corporation is ASSURED EQUITY, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.


